**Subject: Policy of Auction of linkages of Non- Regulated Sector vis a vis renewal of existing FSAs.**

Ministry of Coal introduced the policy of supply of coal through the route of 'Linkage Auction' vide letter no. 23011/51/2015-CPD(Pt-1) dtd. 15th February, 2016

As per this policy Fuel Supply Agreements (FSAs) maturing/due for renewal in 2015-16 onwards are not to be renewed further in case of non-regulated sectors [except FSAs of CPSEs and Fertiliser (Urea)]. Accordingly existing FSAs for non-regulated sector [except FSAs of CPSEs and Fertiliser (Urea)] are not being renewed after completion of their current agreement tenure.
